LIABILITY RELEASE:

I hereby acknowledge that I have voluntarily requested participation for myself or my minor child in equestrian activities at Triple H Riding Center. I am aware that handling horses and riding horses is dangerous and I am voluntarily participating with the knowledge of the danger involved and hereby agree to accept any and all risks of injury or death. Instruction is available to guide, but all risk of injury or death is assumed by the parents or the adult who signs below. Triple H riding Center trains students for all types of riding including but not exclusively harness, dressage, reining, eventing, jumping (stadium- “movable” and cross-country- “immovable”), trail riding, drill team, etc. Each activity offers inherent dangers.

I hereby release and hold harmless Triple H Riding Center, its employees, independent contractors, volunteers, and agree neither I nor my heirs and/or assignees will make claim against, sue, attach the property of or prosecute any of them for injury to myself, my minor child, my horse, my property or to anyone else or for the damage resulting from the negligence or other act or omissions however caused, as a result of my or my child’s engaging in any equestrian or related activity while at Triple H Riding Center.

I have read this agreement and release, and fully understand its content. I am aware that this is a release of liability and contract between Triple H Riding Center and myself. I also acknowledge that there are no warranties implied concerning the facilities or the activities at Triple H Riding Center. I also acknowledge that I am signing this contract of my own free will.
