TRAINING AGREEMENT (the agreement) made _____ (date) by and between: _____, "owner" and Suzanne Brock of Triple H Riding Center (THRC) herein referred to as "trainer." This contract states terms and conditions of training and use of facility for training. The owner willfully trusts trainer to train owners stated horse 3, 4.5 or 6 days per week for an average of 1 hour each day. Please discuss with trainer the appropriate program for your horse. Equine individuals learn at different rates and the trainer works diligently to bring yours along at a rate that benefits it. The trainer will make every attempt to work with the horse/mare by acceptable standards in the industry, and make every attempt to meet the goals listed by the owner. Each horse/mare has individual learning times and training history; this affects the effectiveness of training.

A-3 days a week professional help riding and lesson package keeps horse rider team in top performance \$950 per month.

B-4/5 days a week professional handling will bring a green horse along and ready for the amateur owner in 3-6 months \$1150 per month.

C-the unbroken mare/horse needs a 6 day a week program for 3 months, cost \$1250 per month for 1-6 months depending on equine.
